Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 3.15% in the month of April, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.91%. On a before fees basis the fund returned 3.35% for the month, underperforming the benchmark by 0.71%.

Fund Statistics

At month end, the Fund had a yield to maturity of 7.60% and running yield of 5.61%, with the credit yield spread increasing by 132 bps to 735 bps during the month. The Fund had an interest rate duration of 1.17 years and credit duration of 3.38 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 127 bps during the month to 847 bps.

The top performing leveraged loan industries in April were Food And Drug, Energy and Utility with returns (sector performance in USD terms) of 8.38%, 8.29% and 6.76% respectively. The worst performing loan industries were Aerospace, Retail and Media/Telecommunications with returns of -0.60%, 2.21% and 2.28% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.2% in Electronics, 7.2% in Healthcare, Education and Childcare and 6.8% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 1.1% in Solera, 1.0% in Level 3 Communications and 1.0% in Numericable. During the month, the Fund increased its exposure to AI Aqua, T-Mobile and United Natural Foods; with decreased exposures to Caesars Resort, Diamond Sports and Bell 2016-1A.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2019 and assumes the Fund continues to achieve an equivalent yield for FY2020. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

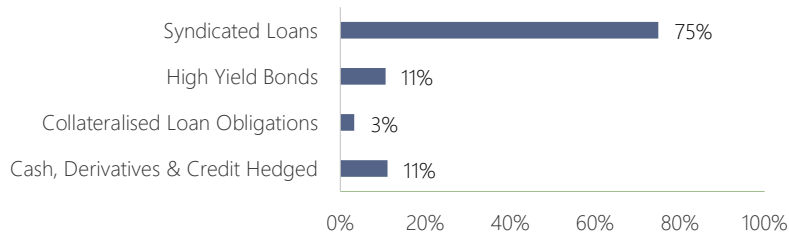

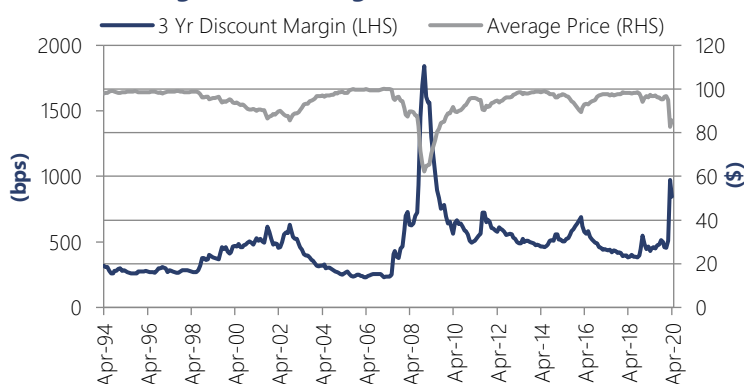
