Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 3.50% in the month of May, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) by 3.35%. On a before fees basis the fund returned 3.57% for the month, outperforming the benchmark by 3.42%.

You need to like tough markets even if they can feel like a rollercoaster ride of volatility. The pandemic markets rallied and swooned over debt in April with a frenetic pace of debt issuance. This was a somewhat surprising outcome Credit markets continue to rally. The major catalysts during May were "re-opening" optimism, ongoing stimulus & vaccine hopes overshadowing weak economic data, weak corporate earnings and escalating US/China tension.

The top contributors to performance included Collateralised Loan Obligations (CLO), Global Syndicated Loans and Bank Capital Securities; whilst the bottom performing contributors included Equity Securities, Sovereign and Global Hybrids.

We now have to look to see how countries around the world will begin to emerge from lock-down and formulate their own strategies for getting back to normal while avoiding second wave activity. We are learning new things everyday about this situation but the longer-term economic impact still remains unclear. We remain invested but concerned about secondary infections and truly horrible fundamental numbers.

Looking beyond the current volatility, we note that Credit is not dependant on high profit growth or dividends that are likely to be cut. It usually sits at the top of the capital structure, protected by equity/shares and secured by assets. Credit spreads continue to benefit from loose monetary policy and central bank market support. The starting point for government bond yields is low and below the current inflation rate. Credit spreads will likely provide an increasingly important way of achieving a positive real return in a potentially low return environment.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

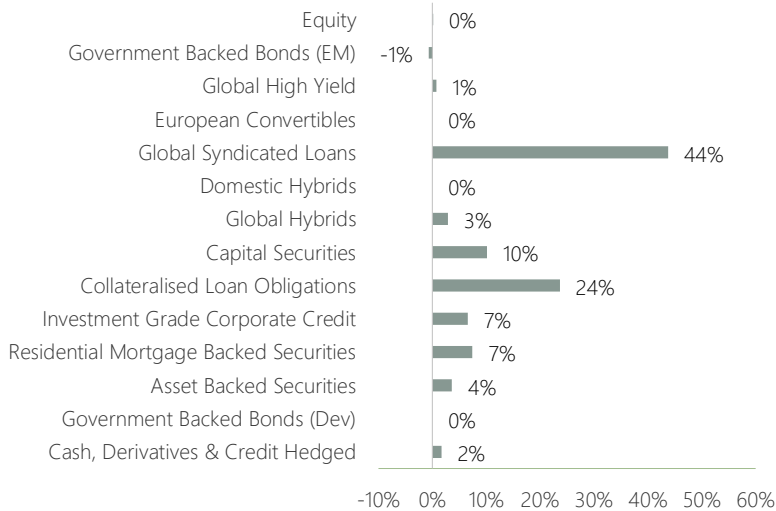
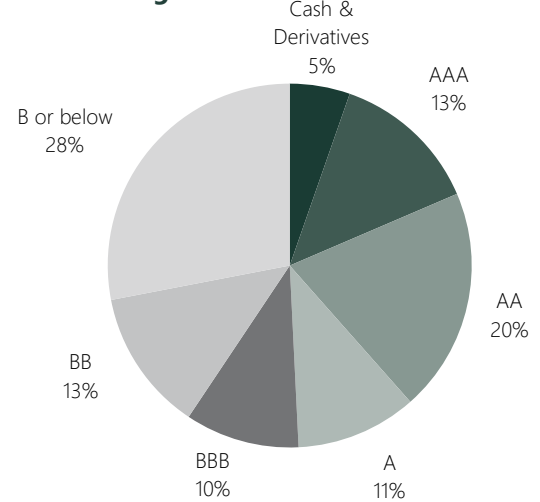
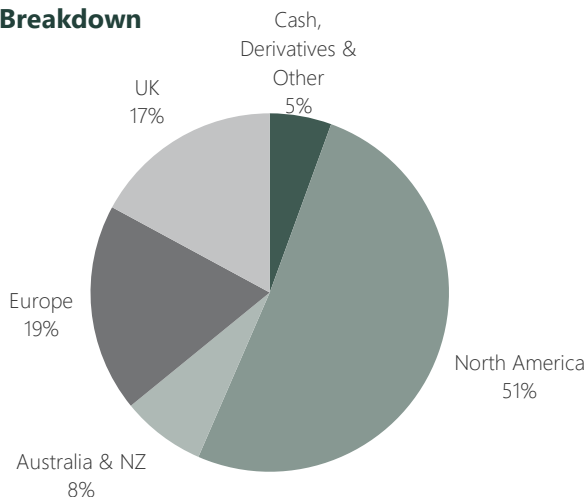
