Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 2.02% for the month, outperforming the benchmark by 2.01%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Global High Yield; whilst the bottom performing contributors included Investment Grade Credit, Residential Mortgage Backed Securities (RMBS) and Collateralised Loan Obligations (CLO).

Portfolio Asset Allocation

During the month, exposures to Basis Trades, Cash and Capital Securities increased, whilst exposures to Global High Yield, Investment Grade Corporate Credit and Collateralised Loan Obligations decreased. Current asset allocations are 10.5% in Global High Yield, 3.9% in Global Hybrids, 46.8% in Global Syndicated Loans, 13.0% in Capital Securities, 15.5% in Collateralised Loan Obligations, 4.0% in Investment Grade Corporate Credit, 4.2% in Residential Mortgage Backed Securities, 0.3% in Equity, 2.0% in Asset Backed Securities and -0.4% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 15.5% in CLO, 11.1% in Banking and 8.4% in Electronics. The Fund's top three company exposures are: 1.8% in Virgin Money Holdings Uk Plc, 1.6% in Cooperatieve Rabobank UA and 1.6% in Galaxy Clo Ltd - 2013-15x.

Leveraged Loan Market

The top performing leveraged loan industries in July were Retail, Metals/Minerals and Healthcare with returns (sector performance in USD terms) of 3.66%, 2.92% and 2.46% respectively. The worst performing loan industries were Aerospace, Media/Telecommunications and Utility with returns of -0.63%, 1.40% and 1.49% respectively.

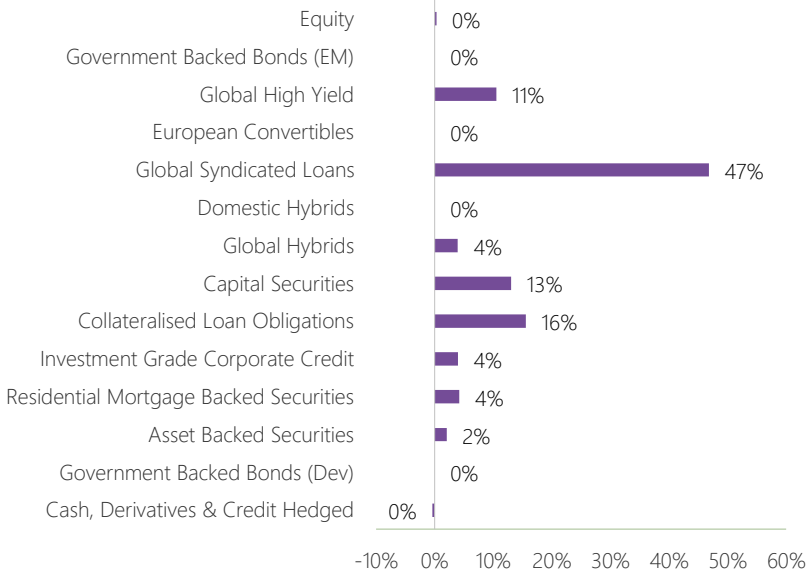
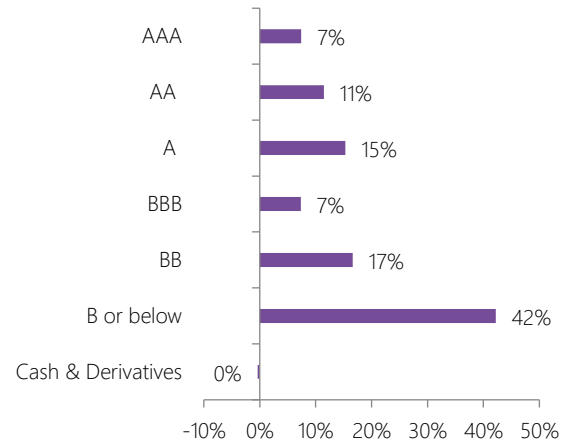
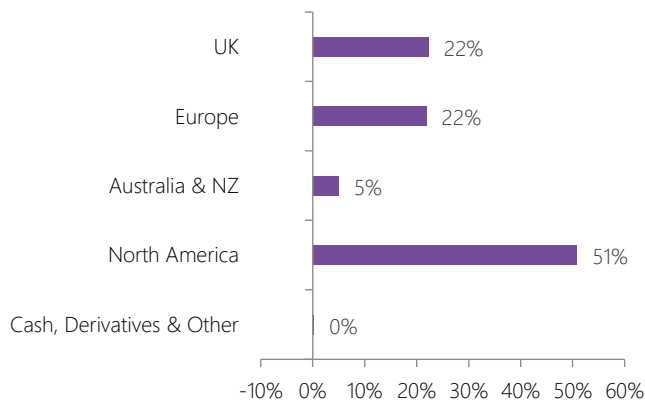
